Re: Halal Terrorism & Haram Terrorism

Dear Sir,

Thank you for your letter of 14 September 2007. In this letter you have mentioned that you have not received my letter of 27 July 2007 which is a report about terrorist acts in Australia. I regret to hear that such an important report has been lost. I believe it has been lost in your office because the post office has confirmed the delivery.

As you are aware , terrorist acts have always been important for the Australian government and usually the government has had a strong and quick response against the terrorist suspects , that's why I have already sent you my report **three times** to make sure that you have received it. I have received the confirmation delivery twice. The report two times by registered mail and one time by express post platinum has been sent to you. The report of terrorist acts which occurred at Martin Place in Sydney Australia on Wednesday 4 July 2007 around 7.30 AM and also the copy of two times confirmation delivery of the post office is attached to this letter.

After sending the report about instructing terrorists , I sent you a fax dated 7 August 2007 to 02 62734102 and I asked you to confirm whether you have received the terrorist acts report or not. I was waiting for a week and I didn't hear from you. As **the terrorist cases are sensitive and we must not waste time even 1 hour** about them I decided not to wait anymore and I sent the report to the Prime Minister John Howard on Thursday 16 August 2007.

I have received a reply letter from the Prime Minister 5 September 2007. As it is mentioned in the letter, the Prime Minister has referred the correspondence to you. So I believe that you should have received it from the Prime Minister by now, but I still have attached it to this letter in case if the letter of the Prime Minister has been lost either.

Dear Sir,

I have asked you **Have you received my report of terrorist acts?** I have asked this question by fax dated 7 August 2007 and I have received your letter of 14 September 2007 that you have answered: **No I have not received it.** Your answer was 38 days after my question. Why so late? You knew that there was a terrorist acts report that you have not received it, why didn't you immediately contact me on the same day you received the fax ? What if the terrorist acts would be regarding an explosion in Sydney during APEC? In that case Sydney could have been exploded by now, who would be blamed?

If I would send a fax to the police regarding the terrorist acts ,for instance report about a placed bomb in a bus, would the police contact me for more details 38 days later?! Or on the same day?

Dear Attorney-General

What is going on in our country?

Would you please answer my following questions:

Why is not the report about terrorist acts taken seriously if the reporter is Muslim?

Why are the responses to the terrorist suspects who are Non Muslim are so soft and slow while the response to the terrorist acts suspects who are Muslim are so strong and fast?

Why Muslim suspect like Dr Mohammad Haneef was arrested quickly but the Non Muslim victim who was instructing terrorists clearly at Martin Place Sydney 4 July 2007 and his statement was broadcasted from Channel 7 still is not in custody?

I have reported to few Australian authorities about this terrorist acts which its suspect is a Non Muslim person but each authority tries not to take responsibility, they pass me to each other like a soccer ball.

First I reported the terrorist acts to Mr. Damian Bugg and I wrote to him : **At this sensitive time that the case of Dr. Mohammad Haneef is almost closed, it is expected from Australian government to show that there is no difference between Muslims and Non Muslims when it comes to breaking the law, to prove that there is no discrimination about terrorism law, and all people will face charges if they commit any kind of terrorist actions whether they are Muslim or Non Muslim, whether it is a Mosque or a Church, whether it is an Islamic radio station or Channel 7....**

DPP said(1 August 2007): you should contact investigation agencies. If you request us we will forward your correspondence to AFP. (Only if I request ! Later I told him: "I never request such a thing from you". He should know what is his duty as an Australian citizen and he must know what to do with a terrorist report. Why should I request him to forward my report to AFP? If the post office delivers a letter of terrorist report to a residential area by mistake , any Australian citizen who gets that mail knows that must forward it to a governmental department or any police station. But Mr. Damian Bugg will forward the terrorist acts report to AFP only and only if the reporter requests him to do so!)

An investigation agency like ASIO has received my report of terrorist acts said(24 August 2007) : ACMA is the appropriate authority. ACMA has received my letter and said (6 September 2007): Attorney-General is appropriate. Probably Attorney-General also wants to refer me to another organisation! I hope this soccer game comes to the end soon.

If the suspect was Muslim, would I still be a soccer ball? Wouldn't the first report to DPP be enough? Wouldn't Mr. Damian Bugg immediately contact you or AFP and the investigation would start quickly and the Muslim suspect would be in custody by now?

Are there two kinds of **permitted terrorism** and **forbidden terrorism** in Australia?

Dear Sir,

Some Muslims ask me:

"If the government can divide terrorism to two kinds of "**OK terrorism**" and "**Not OK terrorism**" in Australia, why shouldn't Muslim clerics be able to divide terrorism to "**Halal terrorism**" and "**Haram terrorism**" in Islam?" What should I answer them?

They ask me "Do we have **Halal terrorism** and **Haram terrorism**?" What should I answer them?

If I say "No we have only Haram terrorism", they would tell me so how come the government has Halal terrorism for Non Muslims? We need to have Halal terrorism too.

Should I tell them that we have two types of terrorism: Halal and Haram?

By the way I note that in my attached correspondence there are 3 different subjects :

1. Report about terrorist acts at Martin place Sydney Australia.
2. Report about offensive statement which not only is insulting Muslims in general and Muslim doctors in particular but also will have some damages and side effects on the health of the Australian society.
3. My complaint from Channel 7 for broadcasting prohibited material.

For the first two subjects ASIO and Attorney-General are appropriate authorities.

For the third one, Australian Communications and Media Authority (ACMA) is the appropriate organisation, so I have already directed my complaint from the "broadcast" to ACMA.

For the fourth time I am sending the attached report about terrorism to you by registered mail and although I will receive a confirmation delivery from the post office, but as the case is important and sensitive I need your confirmation as well, so please let me know and confirm it if this time you successfully receive my letter.
